1. Apologies

Apologies were received from Joke Alexandrou (JA), Chris Furneaux (CF), Peter Taylor (PT) and Bev Mitchell (BM).

2. Previous Minutes

The Minutes of the previous meeting held on Monday 5th September were read and approved.

3. Matters Arising

(a) NS reported that he had visited Hercules Trophy shop and ordered the required trophies. He will fully update the Committee when all of the costs were confirmed because one of the selected trophies was out of stock, therefore a replacement has been ordered.
