# JANUARY REPORT:-

- Completed irrigation upgrade hole 5. Six new sprinklers have been installed and another six have been moved.
- Scrubland bordering holes 1 and 11 has been prined back to define the golf course boundary.
- Landscaped areas have all been pruned and tidied.
- Rough has been sprayed for weeds.
- Selected bunkers have been topped up with sand.
- Vines have been pruned.
- Greens and fairways sprayed with liquid fertiliser.
- Greens sprayed with fungicide and algaecide to treat Dollar Spot and Algae.
- Painted tee markers.
- Replaced broken bell on hole 6 and leaky ball washer on hole 14.
- Minthis were nominated among the final 4 candidates for the STRI International Environmental Golf Course of 2023.
- Landscaped areas were tidied up on holes 4, 5 and 16.
- Bunkers were raked and banks tidied but we are still having major daily issues with dogs and foxes.

## FEBRUARY OBJECTIVES:-

- Move 7 fairway sprinklers on hole 6.
- Install 3 sprinklers on hole 12 left side adjacent to the scrub approaching the green.
- To spray the greens and fairways with liquid fertiliser.
- To apply Plant Growth Hormone to prevent Poa in the greens.
- To apply a preventative insecticide to cull the mole crickets before they reach adult form,
- Paint Hazard Stakes.
- Tree pruning of damaged and low hanging branches.
- Plant extra vines between holes 9 and 18 to the left of the 18<sup>th</sup> ladies tee.
- Hand weed collars for small patches of Kikuyu.
