# 1 Apologies:

## 2 Previous Minutes:

The Minutes of the previous meeting held on Monday 5th January 2019 were read and approved.

## **3 Committee Matters:**

- Stellios advised that given Minthis Golf Club is no longer a society and falls under the Minthis Resort umbrella he believes that an annual club licence is no longer required. Stellios to obtain confirmation of this from the CGF.
- (DM) confirmed that the CGF has advised it is not possible to introduce preferred lies on the drop zone at the 14th hole. The ball must continue to be dropped from knee height when using the drop zone.

## 4 Competitions:

- The admin sheets in respect of April and May were reviewed and agreed, (GN) to place in the folder
- (GN) confirmed the Interclub Team Shirts should arrive within the next week. Cost to be confirmed.
- (CP) advised an enquiry had been received from the Elea ladies section concerning the possibility of introducing a "fun" ladies match between the four clubs. Awaiting further details.
- Discussion took place regarding the "Mud Ball", "Embedded Ball" and "Preferred Lies" rules. (GN) to issue email clarification to members.
- The Knock/Out prize pot for 2019 of 120% payout was agreed by the committee.
- (BM) confirmed there are still a few members who have not paid their knock/out monies. (GN) to issue emails to all those concerned,

- (GN) advised that management had confirmed the date of the Meet & Greet evening to be 3rd April.
- Discussions took place regarding another social evening in July. (BH) to check details and advise shortly.
- Given the success of the recent Dinner Dance, (GN) confirmed consideration will be given to return to Alexander the Great in 2020.

## **6** Golf Course Matters:

- (CF) advised he will be over-seeding the 14th drop zone in the autumn to try and improve the grass coverage.

- There has been a meeting with the golf course architects who confirmed the engineers require one month to repair the "wash out" areas, buggy paths and the building of the tees on the new 10th hole. The architects also looked into the drainage situation on the 5th, 6th and 18th holes. (CF) advised improvement recommendations have been put forward.
- (DM) confirmed that the CGF have reviewed the vines areas between the 1st and 9th holes. This area is to revert back to a red staked "penalty" area. (GN) to issue an email with clarification.
- (CF) to source further "replace divots" signage.

- (BM) to raise a cheque in respect of the charity monies raised in (BH's) captaincy year. (BH) to present the cheque to his charities shortly.
